Airfares reimbursement - travel to and from the vessel	reimbursement for the cost of economy class airfares
Additional travelling expenses reimbursement	reimbursement for any reasonable additional travelling expenses
Communication allowance - floating production facilities	\$3.94 per completed fortnight
Keep reimbursement - floating production facilities	reimbursement for expenses incurred on the facility
Personal accident insurance reimbursement - floating production facilities	reimbursement for death and personal accident insurance cover
Personal illness insurance reimbursement - floating production facilities	reimbursement for insurance against loss of salary due to illness
Hard-lying allowance - not floating production facilities – 2 berth cabin	\$41.31 per day
Hard-lying allowance - not floating production facilities – 4 berth cabin	\$66.15 per day
Shared accommodation allowance - not floating production facilities	\$33.03 per day

Expenses reimbursement	reimbursement of any expenses reasonably incurred
Foreign ports accommodation reimbursement - employer does not provide meals and accommodation	reimbursement for the cost of reasonable accommodation including bed, breakfast and laundry
Living away from home allowance - employee undertaking approved study	\$114.19 per week
Living away from home allowance - employee undertaking approved study - employee has spouse or de facto partner and/or dependent children	\$161.01 per week
Medical examination reimbursement	reimbursement for the cost of prescribed fees
Overalls, oil skins, sou'westers & sea boots reimbursement	reimbursement for the cost of 2 pairs of high visibility overalls per year, oil skins, sou'westers and sea boots
Passport, visas and vaccinations reimbursement	reimbursement for all reasonable charges, fees and expenses incurred
Rest and recreation day allowance - employer does not provide meals and accommodation	\$136.93 per day
Protective & industrial clothing reimbursement	reimbursement for 1/3 of the cost of designated protective and industrial clothing
Special efforts when vessel wrecked or stranded allowance	\$23.18 per hour for the time spent assisting

Taxi fare reimbursement - travel to and from the vessel	reimbursement of taxi fares between home and the airport up to a maximum of \$49.80 per trip
Travelling expenses reimbursement - repatriating to and from home port for leave purposes	reimbursement of costs for travelling to and from the home port
Travelling expenses reimbursement - repatriating to home port at end of employment	reimbursement of the costs for travelling to the home port
